
1. Declare a quorum. Invocation. Pledges.

8. Consideration and possible action to approve a resolution approving the proposal by the Board of Directors of the Falls County Appraisal Office to purchase real property familiarly described as The Brazos Professional Health Clinic Building located at 306 Craik Street, Marlin, Texas to be used for appraisal district operations; said action to be taken pursuant to 6.051 of the Texas Property Tax Code.

Texas Government Code Section:

551.074 Discussing personnel or to hear complaints against personnel
551.076 Considering the deployment, specific occasions for, or implementation of, security personnel or devices
551.082 Considering discipline of a public school child, or complaint or charge against personnel.
551.083 Considering the standards, guidelines, terms, or conditions the board will follow, or will instruct its representatives to follow, in consultation with representatives or employee groups.
551.084 Excluding witnesses from a hearing.
551.086 Deliberate about economic development information.
